

**Christmas 2020 Campaign “Tis the Season to Dream of a White Christmas”
Terms & Conditions**

1) Daily Dream Draw

13 November 2020 – 3 January 2021 (both dates inclusive)

- a) Participants with every S\$30 spend in a single receipt in participating Lendlease malls, from 13 November 2020– 3 January 2021, are eligible to participate in the lucky draw.
- b) The participating Lendlease malls include Jem, Parkway Parade and Paya Lebar Quarter.
- c) Every S\$30 spend will be entitled to 1 lucky draw chance. Lendlease Plus members get x2 chances.
- d) Lucky draw chances are limited to a maximum cap per mall per day, based on the following:

- k) Winners will be informed via phone and email by the stipulated dates. All winners must acknowledge and reply in writing within 5 working days and provide the following details prior to prize collection:
 - Full Name
 - Mobile Number
 - Email Address
 - Last 4 digits of identification number (e.g Sxxxx123I)
- l) Collection of prizes must be made by the winner in person by presenting the NRIC and the original winning email from participating Lendlease malls for verification purpose.

- g) If the shopper cancels a ride booked with the promo code, it will be considered as a successful redemption.

ongoing – 31 Dec 2020 (both dates inclusive)

- a) Shoppers are eligible to enjoy S\$5 off (S\$5 foodpanda promo code) with a minimum order of S\$15 on foodpanda from 9 September till 31 December 2020.
- b) Promo codes are limited to first 1,140 redemptions per mall and are available on a first-come, first-served basis, while stocks last.
- c) Participating F&B tenants must be a valid tenant in Parkway Parade, and their listing on foodpanda must comprise the following postal code:

- xvi. Parkway Parade and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.

The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
