Terms & Conditions

1. Good For Earth

27 Sep – 31 Oct 2021

- a. Promotion period is from 27 Sep – 31 Oct 2021 (both dates inclusive), while stocks last.
- b. Lendlease Plus members who have purchased eco- friendly merchandises from any stores at Parkway Parade, from 27 Sep – 31 Oct 2021, are eligible to redeem bonus Lendlease Plus\$.

**Eco-friendly merchandises are not limited to the list above and will be subjected to Concierge review on a case-by-case basis.*

- f. Redemption is limited to the first 500 Lendlease Plus Members throughout the promotion period, on a first-come first-served basis, while stocks last.

- e. One (1) redemption per Lendlease Plus member throughout the promotion period.
- f. All other standard terms and conditions of the Lendlease Plus Programme apply.
- g. Other Terms of Use apply and further subject to the General Terms and Conditions as set out below.

3. General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Parkway Parade reserves the right to request for proof of age at any time.
- ii. For redemptions at the L1 Concierge Desk (last redemption 9.30pm), original same-day receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.
- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts).
- iv. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- v. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
- vi. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
