

National Day 2022 Campaign: Celebrating Togetherness at Parkway Parade!
Terms & Conditions

1) Singapore Turns 57! *LENDLEASE PLUS MEMBER EXCLUSIVE*

1 August – 21 August 2022 (both days inclusive)

- a) Lendlease Plus Members are eligible to receive 5,700 Plus\$ with a minimum nett spend of \$57 at Parkway Parade, within maximum of two (2) combined same-day receipts.
- b) Nett spend refers to the final payment amount of purchase after all discounts, points redemptions, and retailer vouchers / gift cards redemption.
- c) Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their wallet in-app upon approval of qualifying receipts within 2 working days.
- d) Redemptions must be made on the same day as spend.
- e) Limited to one (1) redemption per Lendlease Plus Member per day, regardless of total amount spent.
- f) Limited to first 10,000 redemptions throughout the Promotion period, on a first-come first-served basis or while stocks last.
- g) All other standard terms and conditions of the Lendlease Plus Rewards Programme apply.
- h) All redemptions are further subject to the General Terms and Conditions as set out below.

2) Weekday Parking Perks *LENDLEASE PLUS MEMBER EXCLUSIVE*

Monday – Friday, 1 August – 21 August 2022 (both days inclusive)

- a) Lendlease Plus members are eligible to redeem \$3 Park Plus\$ at Parkway Parade L2 Concierge Desk with a minimum nett spend of \$20 in a single same-day receipt at Parkway Parade.
- b) Nett spend refers to the final payment amount of purchase after all discounts, points redemption, Lendlease vouchers and retailer vouchers / gift cards redemption.
- c) Limited to a maximum of one (1) redemption per member per day regardless of total amount spent.
- d) Limited to first 100 redemptions per day on a first-come first-served basis or while stocks last.
- e) Redemption must be made on the same day as purchase and available at the Parkway Parade L2 Concierge Desk from 10am to 10pm (last redemption by 9.30pm) daily, unless otherwise stated.
- f) Redemption of Park Plus\$ is only for Lendlease Plus members who have their corresponding vehicle number and IU number registered in the system.
- g) Park Plus\$ are strictly non-refundable, non-exchangeable and non-transferable once redeemed.
- h) Park Plus\$ are valid for 6 months from the date of redemption and validity period cannot be extended.
- i) Upon exiting, Park Plus\$ will be automatically deducted first. Prevailing parking charges may apply after deduction of Park Plus\$.
- j) It may take up to 15 minutes for your Park Plus\$ to be credited. Please check that the Park Plus\$ are reflected on the Park Plus\$ page on your Lendlease Plus mobile app before driving out.

- k) All other standard terms and conditions of the Lendlease Plus Rewards Programme apply.
- l) All redemptions are further subject to the General Terms & Conditions as set out below.

3) Celebrate Togetherness, Discover Rewards *LENDLEASE PLUS MEMBERS EXCLUSIVE*

1 August – 31 August 2022 (both days inclusive)

- a) Lendlease Plus Members are eligible to scan the five (5) QR codes placed around Parkway Parade using the “Scan QR” function on the Lendlease Plus mobile app’s ‘More’ tab from 1 August – 31 August 2022 (both dates inclusive).
- b) The latest version of the Lendlease Plus mobile app must be downloaded in order to participate in the Promotion.
- c) Each QR code contains 500 Plus\$, 600 Plus\$ or 800 Plus\$. Members can earn these Plus\$ by clicking the “Redeem” button on the corresponding page after scanning the QR code.
- d) Each unique QR codes can only be scanned one (1) time per member per day. Subsequent scanning of the same QR code will result in an error message with no Plus\$ awarded.
- e) Limited to first 5,000 redemptions per each unique QR code throughout the Promotion period, on a first-come first-served basis or while stocks last.
- f) 10,000 Plus\$ (equivalent to \$5 Lendlease voucher) will be automatically awarded into the first 1,000 Lendlease Plus Members’ accounts upon successful scanning of all five (5) unique QR codes in Parkway Parade. Limited to one (1) redemption of 10,000 Plus\$ per member throughout the Promotion period.
- g) By participating in this Promotion, you agree to be bound by all terms and conditions of the Lendlease Plus Rewards Programme.
- h) All other standard terms and conditions of the Lendlease Plus Rewards Programme apply.
- i) All redemptions are further subject to the General Terms & Conditions as set out below.

4) Lendlease x PACE Campaign Promotional Vouchers

- a) These terms and conditions (Voucher Terms) govern the use and redemption of promotional vouchers and promotional codes (Voucher Codes) distributed by Pace for the promotional campaign (Lendlease-Pace Campaign) between Pace Enterprise Pte Ltd (Pace) and Lendlease Retail Pte Ltd (Lendlease) commencing from 1 August 2022 to 31 October 2022 (Campaign Period). By using and redeeming the Voucher Codes, you agree to be bound by these Voucher Terms, in addition to the Terms of Service (TOS) on the use of the Pace Platform which are incorporated by reference into these Voucher Terms. All capitalised terms used herein shall have the meaning ascribed in the TOS unless otherwise provided. We reserve the right to change these Vouchers Terms at any time and without notice. It shall be your responsibility to review the prevailing Vouchers Terms on the redemption of Voucher Codes before making any Pace Buy transaction.
- b) To redeem the Vouchers, the applicable Voucher Code must be applied at the check-out payment page on the Pace Platform. The total amount payable by the Pace Platform user will be reduced by the value of the Vouchers, with the remaining balance to be split into the number of instalments shown in the Pace Platform.
- c) It is the Pace Platform user’s sole responsibility to carefully review the check-out payment page to ensure that Vouchers are applied before proceeding with payment. If the Pace Platform user fails to

do so for any reason, (a) Pace and Lendlease shall not be responsible for providing the Pace Platform user the benefit of the Vouchers in any form, and (b) the Pace Platform user shall not hold Pace and Lendlease or the Merchant Member responsible to refund, reverse or otherwise void the Pace Buy transaction.

- d) The Vouchers can only be used once for a single Pace Buy transaction per Pace user. Additional specific conditions may apply for the redemption of the Vouchers (Specific Conditions). Pace Platform users can view these Specific Conditions for each individual Voucher in the Pace Platform at Account > Vouchers and Account > Refer and Earn.
- e) Unless otherwise stated in the Specific Conditions, a Voucher cannot be “stacked” or used in combination with any other Voucher(s), promotion, or discount through the Pace Platform.
- f) There shall be no extension of the validity period for redemption of any Voucher Code.
- g) Under no circumstances will Vouchers be exchangeable, refundable, or substituted for cash, credit, discounts, or any form of goods or services.
- h) If the Pace Platform user's Pace Buy transaction is reversed, refunded, or subject to a Chargeback, whether wholly or partially, and for any reason, Neither Pace nor Lendlease shall be responsible for refunding to the Pace Platform user the Vouchers in any form. For the avoidance of doubt, if the Pace Platform user has redeemed a Voucher for a Pace Buy transaction and such Pace Buy transaction is subsequently reversed, refunded, or subject to a Chargeback, the redeemed Voucher shall not be available for redemption for a different Pace Buy transaction.
- i) Neither Pace nor Lendlease will be responsible for providing the Pace Platform user with any replacement Vouchers, cash, credit, refunds, discounts, or any form of compensation in any instances, including the following: discontinued or cancelled Vouchers, Vouchers that have been fully redeemed prior to the validity period as provided in the Specific Conditions; improper use of Vouchers (as we may determine in our sole discretion), the Pace Platform user's omission or failure to apply the Vouchers before completing payment, and inability to apply or redeem Vouchers due to any technical issues, whether attributable to the Pace Platform or not.
- j) Pace and Lendlease reserve the right in our sole discretion to cancel, modify, limit, or revoke the use of any Voucher at any time and for any reason. Without prejudice to the generality of the foregoing, examples of such instances would include any suspicious or fraudulent purchasing activity or Voucher use, and the use of Vouchers in bad faith by multiple Pace Accounts or multiple checkouts associated with the same Customer Member or group of Customer Members.

4.1. National Day Special on PACE

1 August – 31 August 2022 (both days inclusive)

- a) The National Day Special Voucher Code may be redeemed by new and existing Pace Platform users for 28% off the purchase value capped at a total of S\$28 applicable to Pace Buy transactions at participating retail stores in 313@somerset, Jem, Parkway Parade, and Paya Lebar Quarter (collectively, “Lendlease Malls”). - a) The Pace User Exclusive Voucher Code may be redeemed by new and existing Pace Platform users for S\$10 off the purchase value with a minimum spend of S\$40 applicable to Pace Buy transactions at participating retail stores in the Lendlease Malls. - b) The Pace User Exclusive Voucher Code shall be valid for redemption during the Campaign Period and shall be limited to the following quantities, on a first-come, first-served basis:
- i. the first 2,000 redemptions for each Lendlease Mall from 1 to 31 August 2022;
 - ii. the first 2,000 redemptions for each Lendlease Mall from 1 to 30 September 2022; and
 - iii. the first 2,000 redemptions for each Lendlease Mall from 1 to 31 October 2022

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Parkway Parade reserves the right to request for proof of age at any time.
- ii. For redemptions at the L2 Concierge Desk (last redemption 9.30pm), original same-day receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.
- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after all discounts, points redemption and retailer vouchers/gift cards redemption.
- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- vi. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- vii. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
- viii. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.

- ix. - xii. By participating in the Promotion, persons will be deemed to have read, understood and agreed to be bound by these rules and any other requirements set out in any related promotional material and all amendments, additions, replacements, modifications as may be made from time to time.
- xiii. Personal information you provide in registering to participate in the Promotions, or otherwise deal with Parkway Parade or Prime Asset Holdings Ltd., may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Parkway Parade and Prime Asset Holdings Ltd. (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- xiv. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xv. Parkway Parade and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
- xvi. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- xvii. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xviii. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xix. In the event of dispute, Management's decision shall be final and no correspondence will be entertained.
- xx. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xxi. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
