

Season's Surprises at Lendlease Malls (11 November – 25 December 2022)

Terms and Conditions

1) Leave A Joyous Mark

11 November 2022 – 25 December 2022 (both dates inclusive)

- a) Shoppers are eligible to redeem one (1) piece of festive Christmas gift wrapper with every S\$30 nett spend in a single receipt at Parkway Parade.
- b) Redemption must be made on the same day of purchase at the L2 Concierge or L2 Gift Wrapper Redemption Booths.
- c) Limited to a maximum of three (3) redemptions per shopper per day, regardless of total amount spent.
- d) Limited to first 40,000 redemptions throughout the entire promotion period, on a first-come first-served basis or while stocks last.

4) Citi Credit Cardmembers Special

- d) To receive the additional S\$10 Lendlease voucher, the eligible Citi Credit Cardmember must present up to three (3) same-day Parkway Parade receipts, credit card charge slips and corresponding Citibank Credit Card at L2 Concierge only (last redemption at 9.30pm).
