

Hot Deals Freshly Served (“Promotion”) Terms & Conditions

1. Fresh Deals, Weekly Drops

25 May, 1, 8, 15, 22, 29 June and 6 July 2026

- 1.1. Lendlease Plus Members are eligible to redeem S\$10 or S\$50 retailers’ E-Vouchers with 1,000 Plus\$ or 5,000 Plus\$ respectively, on the Lendlease Plus mobile app “Rewards” section during the campaign period.
- 1.2. Retailers’ E-Vouchers will be launched at 12pm on 25 May, 1, 8, 15, 22, 29 June and 6 July 2026 and usable only at participating Lendlease mall stores as stated in the terms & conditions of each E-Voucher. Detailed terms and conditions stated on respective E-Vouchers apply.

2. Freshly Baked Rewards
