

**Surprises Await (2 Sep – 27 Oct 2024)**

**Terms & Conditions**

**1) Delightful Plus\$ *LENDLEASE PLUS MEMBERS EXCLUSIVE***

2 Sep – 27 Oct 2024 (both dates inclusive)

- a) Lendlease Plus Members are eligible to redeem 10,000 Plus\$ with a minimum nett spend of S\$180 at Parkway Parade, within a maximum of three (3) combined same-day receipts.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
