

## **Parkway Parade – Grab These Offers 2025 (“Promotion”)**

### **Terms and Conditions**

#### **1. Weekday Rewards**

9 May – 20 June 2025 (both dates inclusive)

- 1.1. Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of **S\$150** on Mondays to Fridays (excluding public holidays) at Parkway Parade, within a maximum of three (3) combined same-day receipts.
- 1.2. Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- 1.3. Public holiday refers to 12 May 2025.
- 1.4. Limited to the first 10,000 redemptions throughout the Promotion period at 1 redemption per member per day, on a first come, first served while stocks last basis.
- 1.5. Members can clock their spends by
  - 1.5.1. Presenting their Lendlease Plus Member QR code at Instant Earn participating stores during the point-of-sale to earn the Plus\$ instantly. Instant Earn participating stores can be identified by the ‘Accepts Instant Plus\$ Earning’ icon on the Lendlease Plus mobile app’s respective store pages; or
  - 1.5.2. Uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to member’s in-app wallet upon approval of qualifying receipt(s) within one (1) working day.
- 1.6. Instant Earn participating stores can be identified by the ‘Accepts Instant Plus\$ Earning’ icon on the Lendlease Plus mobile app’s respective store pages.
- 1.7. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- 1.8. All redemptions are further subject to the General Terms and Conditions as set out below.

#### **2. Weekday 5X Bonus Plus\$**

9 May – 20 June 2025 (both dates inclusive)

- 2.1. Lendlease Plus Members are eligible to receive 5X Plus\$ on Mondays to Fridays (excluding public holidays), with a minimum nett spend of **S\$10** within a single receipt at Parkway Parade clocked via Instant Earn participating stores at point-of-sale.
- 2.2. Public holiday refers to 12 May 2025.
- 2.3. 5X Plus\$ will be awarded based on 1X Base Plus\$ and 4X Bonus Plus\$.
- 2.4. Limited to first 200 approved transactions per day, on a first come, first served while stocks last basis.
- 2.5. The bonus Plus\$ is capped daily at 10,000 Plus\$ and 20,000 Plus\$ for Basic Member and Premium Member respectively.

- 3.1. Lendlease Plus Members are eligible to redeem S\$10 retailers' E-Vouchers with **1,000 Plus\$** on the Lendlease Plus mobile app, "Rewards" section during the campaign period.
- 3.2. Retailers' E-Vouchers will be launched at 12pm on 9, 16, 23, 30 May & 6, 13, 20 June 2025 and usable only at Lendlease Mall outlets as stated in the T&Cs of each E-Voucher. Detailed terms and conditions stated on respective E-Vouchers apply.
- 3.3. Redemptions are limited to a maximum of two (2) E-Vouchers per member per voucher type on a first come, first served while stocks last basis.
- 3.4. To utilise the E-Voucher(s), members must present the unique QR code of the redeemed E-Voucher in their Lendlease Plus mobile in-app wallet to the shop staff prior to payment for scanning using the JeriPay terminal.
- 3.5. Limited to usage of maximum two (2) E-Vouchers per transaction, unless otherwise stated.
- 3.6. A minimum nett spend of S\$15 will be required to utilise one (1) E-Voucher and a minimum nett spend of S\$30 will be required to utilise two (2) E-Vouchers.
- 3.7. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilisation, points redemption, membership credits, gift cards, coupons, stored value cards spend and vouchers from Lendlease, retailers, or other external partners.

Till 31 December 2025

There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- 4.7. Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.

- 5.3. 5,000 Plus\$ will be awarded into members' accounts instantly upon successful membership registration.

- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilisation, points redemption, membership credits, gift cards, coupons, stored value cards spend and vouchers from Lendlease, retailers, or other external partners.

- xv. Parkway Parade Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xvi. Parkway Parade Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
