

## **Parkway Parade – Carting Endless Rewards (“Promotion”)**

### **Terms and Conditions**

#### **1) Plus\$ Perks** LENLEASE PLUS MEMBERS EXCLUSIVE

8 Sep – 19 Oct 2025 (both dates inclusive)

- a) Lendlease Plus Members are eligible to redeem 10,000 Plus\$ with a minimum nett spend of S\$200 at Parkway Parade, within a maximum of three (3) combined same-day receipts.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) Redemption is limited to one (1) redemption per member per day regardless of total amount spent.
- d) Limited to the first 10,000 redemptions throughout the Promotion period, on a first-come, first-served basis or while stocks last.
- e) Plus\$ will be credited instantly to in-app wallet upon successful transaction at the point of sale at instant earn participating stores, or upon approval of qualifying receipt(s) within 1 working day respectively.
- f) Redemption must be made on the same day as spend.
- g) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.

#### **2) E-Vouchers Extravaganza** LENLEASE PLUS MEMBERS EXCLUSIVE

- c) E-Vouchers awarded are valid for use at Parkway Parade within three (3) months from date of issuance only.

### 3) HSBC Credit Cardmembers Exclusive

- a) HSBC Credit Cardmembers who charge a minimum nett spend of S\$200 ("Qualifying Spend") at Parkway Parade from 8 September – 19 October 2025, are eligible to redeem a S\$5 Lendlease voucher.
- b) HSBC Credit Cardmembers who charge a minimum nett spend of S\$300 ("Qualifying Spend") at Parkway Parade from 8 September – 19 October 2025, are eligible to redeem a S\$10 Lendlease voucher.
- c) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- d) S\$5 Lendlease voucher shall be issued in the form of one (1) piece of S\$5 Lendlease E-Voucher to qualifying Lendlease Plus Members or S\$5 Lendlease voucher to qualifying non-members. - e) S\$5 Lendlease E-Voucher and S\$5 Lendlease voucher are limited to the first 2,000 HSBC Credit Cardmembers on a first-come, first-served basis and while stocks last. S\$10 Lendlease E-Voucher and S\$10 Lendlease voucher are limited to the first 1,000 HSBC Credit Cardmembers on a first-come, first-served basis and while stocks last.
- f) The Qualifying Spend is based on up to three (3) combined same-day receipts.
- g) In meeting the Qualifying Spend, HSBC Credit Cardmembers are not allowed to use prepaid cards, as a form of top-up. Transactions made at event fairs (by non-Parkway Parade retailers), office tower tenants, banks, money-changing facilities, trade-in of products, medical, dental, Ecoring, My First Skool, Ma Kuang TCM, Cars International and retailers located at Level 5, top-up card machines or transactions in connection to the car park, purchase of cash cards/ iTunes gift cards/ gift vouchers/ membership/ insurances/ travellers' cheques/ lottery tickets, payment of bills at any Parkway Parade retailers, and purchase of Lendlease vouchers from the Concierge Desk are strictly excluded. - h) For transactions made via contactless payment e.g. Apple Pay, FavePay, GrabPay etc. that are without Card Charge Slip, HSBC Credit Cardmembers will be required to present HSBC Singapore app reflecting spending amount for verification prior to redemption.
- i) To receive the S\$5 / S\$10 Lendlease E-Voucher(s) or S\$5 / S\$10 Lendlease voucher(s), the eligible HSBC Credit Cardmember must present up to a maximum of three (3) same-day Parkway Parade receipts, Card Charge Slip and corresponding HSBC Credit Card at Parkway Parade L2 Concierge Desk from 11.30am – 8.30pm only. Concierge will only issue the S\$5 / S\$10 Lendlease E-Voucher(s) or S\$5 / S\$10 Lendlease voucher(s). Lendlease Plus Members are required to clock their spends at the point of sale at instant earn participating stores or submit their eligible purchase receipt on the Lendlease Plus app to earn Plus\$ based on their qualified transaction.

- j) Redemption must be made on the same day as purchase and is limited to one (1) redemption per HSBC Credit Cardmember per day.

**4) A Parade of Dining Delights** LENLEASE PLUS MEMBERS EXCLUSIVE  
Till 31 December 2025

- a) Lendlease Plus Members are eligible to receive a S\$5 Lendlease E-Voucher with a minimum nett spend of S\$80 at participating F&B stores in Parkway Parade on weekdays (Mondays – Fridays, excluding Public Holidays), within a maximum of two (2) combined same-day receipts.
- b) This promotion is only applicable for purchases made from participating F&B stores listed [here](#).
- c) E-Vouchers awarded are valid for use at Parkway Parade within six (6) months from date of issuance only.
- d) Redemption is limited to one (1) redemption per member per day regardless of total amount spent.
- e) Limited to the first 100 redemptions per weekday (Mondays – Fridays, excluding Public Holidays), on a first-come, first-served basis or while stocks last.

- f) The E-Voucher will be credited instantly to in-app wallet upon a successful transaction at the point of sale at instant earn participating stores, or upon approval of qualifying receipt(s) within one (1) working day respectively. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- g) Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.
- h) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- i) All redemptions are further subject to the General Terms and Conditions as set out below.

## **5) Evening Parking Perk**

- a) Shoppers are eligible to receive a S\$2 parking coupon with a minimum nett spend of S\$30 at Parkway Parade from 6pm, within a maximum of two (2) combined same-day receipts.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) The time indicated on the same-day receipts must be from 6pm/18:00 onwards, to qualify for the redemption.
- d) Redemption must be made on the same day as purchase at L2 Concierge Desk from 6pm – 8.30pm only and is limited to one (1) redemption per shopper per day, regardless of total amount spent on a first-come, first-served basis or while stocks last. Concierge will only issue the S\$2 parking coupons. Lendlease Plus Members are required to clock their spends at the point of sale in instant earn participating stores or submit their eligible purchase receipt on the Lendlease Plus app to earn Plus\$ based on their qualified transaction.
- e) S\$2 parking coupons awarded are valid for use at Parkway Parade's carpark on the same day of issuance only, and cannot be exchanged for other denominations, cash or vouchers.
- f) Lost, damaged, defaced, stolen, expired and/or void parking coupons will not be replaced.
- g) Only 1 parking coupon shall be utilised used per exit. To utilise the S\$2 parking coupon, please note the following:
  - Remove the cash card from vehicle's IU before reaching the exit gantry. Full parking amount will be deducted if the cash card is not removed upon reaching the exit gantry.
  - Insert parking coupon into the 'Scan Ticket' slot of the exit gantry.
  - For any excess parking charges after deduction of S\$2 parking discount, please reinsert cash card into the vehicle's IU for payment.
  - Please ensure there is sufficient fund in the cash card before exiting.
  - For Lendlease Plus Members with registered vehicle in the Lendlease Plus app and existing Park Plus\$ stored in e-wallet, please note the Park Plus\$ be deducted first.
- h) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- i) All redemptions are further subject to the General Terms and Conditions as set out below.

## 6) Lendlease Plus Sign-Up Exclusive

Till 31 December 2025

- a) New Lendlease Plus Member sign-ups via the Lendlease Plus mobile app or lendleaseplus.com with promo codes 'LLPPP25' shall be awarded with 5,000 Plus\$.
- b) Promo code 'LLPPP25' is limited to the first 3,500 for new and eligible sign-ups.
- c) 5,000 Plus\$ will be awarded into members' accounts instantly upon successful membership registration.
- d) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- e) All redemptions are further subject to the General Terms and Conditions as set out below.

## General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Parkway Parade reserves the right to request for proof of age at any time.

- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilization, points redemption, membership credits, gift cards, coupons, stored value cards spend and vouchers from Lendlease, retailers, or other external partners.
- v. All redeemed and/or utilised E-Vouchers are strictly non-refundable, non-exchangeable or non-transferable for physical vouchers, Lendlease Plus\$, cash or any other form.
- vi. A Member may redeem not more than S\$2,000 worth of Lendlease Plus\$ to Lendlease Physical Vouchers per day at the Concierge Desk.

- xiii. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.
- xiv. By entering our premises, you consent that any images, audio (including voices) and video footages, interviews, and/or likeness taken may be used by Lendlease for publicity and/or marketing purposes.
- xv. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xvi. Parkway Parade and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
- xvii. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
- xviii. The Management reserves the right to vary these Terms and Conditions herein at any time at its absolute discretion without prior notice.
- xix. In the event of any inconsistency between these Terms and Conditions with any other form of publicity collaterals relating to the Promotion, these Terms and Conditions shall prevail.
- xx. In the event of dispute, Management's decision shall be final and no correspondence will be entertained.
- xxi. This Promotion, and these Terms and Conditions are governed by the law of the Republic of Singapore and all participants are subjected to the exclusive jurisdiction of its courts in the determination of any matter or dispute arising in connection therewith.
- xxii. These Terms and Conditions listed are not intended to confer rights by a third party under the Contracts (Rights of Third Parties) Act (Cap.53B) to enforce any provision of these Terms and Conditions.
