

## **You Won't Believe It's Trash – Trash To Eden (11 Jul – 1 Sep 2024)**

### **Terms and Conditions**

#### **1. Plus\$ in Bloom** *Lendlease Plus Members Exclusive*

11 July – 1 September 2024 (both dates inclusive)
