

Parkway Parade March Campaign 2023 (6 March – 26 March 2023)

Terms and Conditions

- 1) **Assemble Your Plus\$ Rewards** *LENDLEASE PLUS MEMBERS EXCLUSIVE*
6 March 2023 – 26 March 2023 (both dates inclusive)
 - a) Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of S\$200 at Parkway Parade, within maximum of three (3) combined same-day receipts.
 - b) Nett spend refers to the final payment amount of purchase after all discounts, points redemption, Lendlease vouchers and retailer vouchers / gift cards redemption.
 - c) Limited to first 5,000 redemptions throughout the Promotion period, on a first-come first-served basis or while stocks last.
 - d) Limited to one (1) redemption per member per day regardless of total amount spent.
 - e) Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their wallet in-app upon approval of qualifying receipts within 2 working days.
 - f) Redemptions must be made on the same day as spend.
 - g) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
 - h) All redemptions are further subject to the General Terms and Conditions as set out below.

- 2) **Citi Exclusive Bonus** *LENDLEASE PLUS MEMBERS EXCLUSIVE*
6 March 2023 – 26 March 2023 (both dates inclusive)
 - a) Citi Cardmember who charge a minimum nett spend of S\$200 (“Qualifying Spend”) to his/her Singapore-issued Citi Card at Parkway Parade, from 6 March to 26 March 2023, are eligible to redeem an additional S\$5 Lendlease E-Voucher.
 - b) Nett spend refers to the final payment amount of purchase after all discounts, points redemption, Lendlease vouchers and retailer vouchers / gift cards redemption.
 - c) The Qualifying Spend is based on up to (3) combined same-day receipts. In meeting the Qualifying Spend, Citi Cardmembers are NOT allowed to use prepaid cards, as a form of top-up.  - d) To receive the additional S\$5 Lendlease E-Voucher, the eligible Citi Cardmember must present up to three (3) same-day Parkway Parade receipts, Card Charge Slips, and corresponding Citi Card at Parkway Parade L2 Concierge only (last redemption at 9.30pm).
 - e) Redemption must be made on the same day as purchase and is limited to one (1) redemption per Citi Cardmember per day.

3) **Weekday Parking Perks** *LENDLEASE PLUS MEMBERS EXCLUSIVE*

6 March 2023 – 24 March 2023 (both dates inclusive)

- a) Lendlease Plus members are eligible to redeem \$3 Park Plus\$ at Parkway Parade L2 Concierge Desk with a minimum nett spend of S\$50 in a single same-day receipt at Parkway Parade.
- b) Nett spend refers to the final payment amount of purchase after all discounts, points redemption, Lendlease vouchers and retailer vouchers / gift cards redemption.
- c) Available from Mondays – Fridays only and limited to a maximum of one (1) redemption per member per day regardless of total amount spent.
- d) Limited to first 100 redemptions per day on a first-come first-served basis or while stocks last.
- e) Redemption must be made on the same day as purchase and available at the Parkway Parade L2 Concierge Desk from 10am to 10pm (last redemption by 9.30pm) daily, unless otherwise stated.

- j) It may take up to 15 minutes for your Park Plus\$ to be credited. Please check that the Park Plus\$ are reflected on the Park Plus\$ page on your Lendlease Plus mobile app before driving out.
- k) All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- l) All redemptions are further subject to the General Terms and Conditions as set out below.

General Terms and Conditions

- i. Subject to the criteria set out herein, shoppers must be at least sixteen (16) years of age as at the date of participation to qualify for any promotions or redemption events forming part of the Promotion. Parkway Parade reserves the right to request for proof of age at any time.
- ii. For redemptions at the L2 Concierge (last redemption 9.30pm), original same-day receipts must be presented to qualify. Back-dated receipt(s) are not permitted for redemptions.
- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after all discounts, points redemption and retailer vouchers/gift cards redemption.
- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- vi. There will strictly be no conversion of redeemed e-voucher to physical voucher.
- vii. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
- viii. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption. Payment made by rebates from credit cards and other card rebates and/or discounts are not accepted for redemption.
- ix. - xv. Parkway Parade and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.

The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
