Terms and Conditions

1. Lendlease Plus In-App Game: Jolly Rush LENDLEASE PLUS MEMBERS EXCLUSIVE

7 November 2025 – 4 January 2026 (both dates inclusive)

- 1.1. Lendlease Plus Members are eligible to redeem one (1) game chance with a minimum nett spend of S\$20 in a single receipt.

4. Citi Mastercard Cardmembers Exclusive

- 4.1. Citi Mastercard Cardmembers who charge a minimum nett spend of S\$250 (“Qualifying Spend”) at Parkway Parade, from 7 November 2025 – 4 January 2026, are eligible to redeem a S\$10 Lendlease voucher.

e.g. Fave Pay, Grab Pay, Kris Pay and ShopBack etc. are strictly excluded. For instalment payments, and deposits, only nett amount paid on the same day of redemption is valid. For transactions made via contactless payment e.g. Apple Pay, Samsung Pay that are without Card Charge Slip, Citi Mastercard Cardmembers will be required to present Citibank SG app reflecting spending amount for verification prior redemption.

- 4.8. To receive the S\$10 Lendlease voucher/E-Voucher(s), the eligible Citi Mastercard Cardmember must present up to a maximum of three (3) same-day Parkway Parade receipts, Card Charge Slip, and corresponding Citi Mastercard at Parkway Parade L2 Concierge Desk only, from 11.30am to 8.30pm.
- 4.9. Redemption must be made on the same day as purchase and is limited to one (1) redemption per Citi Mastercard Cardmember per day.

All disputes about quality or performance of the Redeemed Products shall be resolved directly with the store that sold the Redeemed Products.

There will strictly be no conversion of redeemed E-Voucher to physical Voucher.

 - For any excess parking charges after deduction of S\$2 parking discount, please reinsert cash card into the vehicle's IU for payment.
 - Please ensure there is sufficient fund in the cash card before exiting.
- 7.8. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- 7.9. All redemptions are further subject to the General Terms and Conditions as set out below.

8. Lendlease Plus Sign-up Exclusive
