

## March Campaign 2024: March Into Holiday Vibes

### Terms & Conditions

#### 1) **Shop To Your Heart's Content** *LENLEASE PLUS MEMBERS EXCLUSIVE*

7 March – 7 April 2023 (both dates inclusive)

- a) Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of \$200 at Parkway Parade, within a maximum of three (3) combined same-day receipts.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) Limited to the first 7,000 redemptions throughout the Promotion period, on a first-come first-served basis or while stocks last.

- d) Limited to first 2,000 redemptions on a first-come, first-served basis or while stocks last.

## General Terms and Conditions

- iii. Only original receipts are accepted. Credit/debit card slips & NETS transaction slips are not acceptable, unless presented together with corresponding original receipts.
- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilization, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
