

MID-AUTUMN 2023: MOONLIT INDULGENCE AT PARKWAY PARADE

Terms and Conditions

1. **Harvest Your Plus\$** LENLEASE PLUS MEMBERS EXCLUSIVE

4 – 29 Sep 2023 (both dates inclusive)

- a. Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of \$200, within a maximum of 3 combined same-day receipts.
- b. Nett spend refers to the final payment amount of purchase after deduction of all discounts, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- c. Limited to the first 5,000 redemptions throughout the Promotion period, on a first-come first-served basis or while stocks last.
- d. Redemption must be made on the same day as purchase and is limited to one (1) redemption per member per day, regardless of total amount spent.
- e. Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their in-app wallet upon approval of qualifying receipts within 2 working days.
- f. All other standard Terms and Conditions of the Lendlease Plus Rewards Programme apply.
- g. All redemptions are further subject to the General Terms and Conditions as set out below.

2. **Citi Mastercard® Exclusive**

4 – 29 Sep 2023 (both dates inclusive)

- a. Citi Mastercard Cardmembers who charge a minimum nett spend of S\$120 (“Qualifying Spend”) at Parkway Parade, from 4 – 29 Sep 2023, are eligible to redeem one (1) S\$10 Lendlease voucher.
- b. Nett spend refers to the final payment amount of purchase after deduction of all discounts, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- c. \$10 Lendlease voucher shall be issued in the form of one (1) piece of \$10 Lendlease E-Voucher to qualifying Lendlease Plus Members or one (1) piece of \$10 physical Lendlease voucher to qualifying shoppers.
- d. The Qualifying Spend is based on up to three (3) combined same-day receipts. In meeting the Qualifying Spend, Citi Mastercard Cardmembers are NOT allowed to use prepaid cards, as a form of top-up. Transactions made at event fairs (by non-Parkway Parade retailers), office tower tenants, banks, money-changing facilities, trade-in of products, medical, dental, Ecoring, My First Skool, Dunlopillo, Ma Kuang TCM, Miao by Multiflora, Cars International and retailers located at Level 5, top- up card machines or transactions in connection to the car park, purchase of cash cards/ iTunes gift cards/ gift vouchers/ membership/ insurances/ travellers’ cheques/ lottery tickets, payment of bills at any Parkway Parade retailers, and purchase of Lendlease vouchers from the Concierge Desk are strictly EXCLUDED. For instalment payments, and deposits, only nett amount paid on the same day of redemption is valid. For transactions made via contactless payment e.g. Apple Pay, FavePay, GrabPay etc. that are without Card Charge Slip, Citi Mastercard Cardmembers will be required to present Citi SG app reflecting spending amount for verification prior redemption.

- e. To redeem S\$10 Lendlease voucher, the eligible Citi Mastercard Cardmember must present up to a maximum of three (3) same-day Parkway Parade receipts, Card Charge slip and corresponding Citi Mastercard at L2 Concierge Desk only (last redemption at 9.30pm).
- f. Redemption must be made on the same day as purchase and is limited to one (1) redemption per Citi Mastercard Cardmember per day, regardless of total amount spent.
- g. The S\$10 Lendlease voucher is limited to the first 1,500 Citi Mastercard Cardmember redemptions only on a first-come, first-served basis and while stocks last.

- a. Redeem an admission ticket to the Mid-Autumn craft workshop with a minimum nett spend of \$60, within a maximum of 2 combined same-day receipts.

- iv. Nett spend refers to the final payment amount of purchase after deduction of all discounts, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.
- vi. There will strictly be no conversion of redeemed E-Voucher to physical Voucher.
- vii. For instalment payments, deposits and trade-in products, only nett amount paid on the same day of redemption is valid.
