

**Mid-Year Campaign – Grab These Offers (10 May – 23 June 2024)**

**Terms & Conditions**

**1) Weekday Grabs** *LENDLEASE PLUS MEMBERS EXCLUSIVE*

10 May – 23 June 2024 (both dates inclusive)

- a) Lendlease Plus Members are eligible to receive 10,000 Plus\$ with a minimum nett spend of S\$200 on weekdays at Parkway Parade, within a maximum of three (3) combined same-day receipts.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) Redemption is available from Monday to Friday only and is limited to one (1) redemption per member per day regardless of total amount spent.
- d) Redemption is not valid on public holidays on 22 May (Wednesday) and 17 June (Monday) 2024.
- e) Limited to the first 10,000 redemptions throughout the Promotion period, on a first-come, first-served basis or while stocks last.
- f) Members can clock their spends by uploading receipts via the Lendlease Plus mobile app. Plus\$ will be credited to their in-app wallet upon approval of qualifying receipts within two (2) working days.

**2) Citi Cardmembers Exclusive**

10 May – 23 June 2024 (both dates inclusive)

- a) Promotion period is from 10 May to 23 June 2024 (both days inclusive), while stocks last.
- b) Citi Cardmembers who charge a minimum nett spend of S\$250 (“Qualifying Spend”) at Parkway Parade, from 10 May to 23 June 2024, are eligible to redeem a S\$10 Lendlease voucher.
- c) Citi Cardmembers with receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- d) Nett spend refers to the final payment amount of purchase after deduction of all discounts, Plus\$ utilization, points redemption, membership credits, gift cards, coupons, and vouchers from Lendlease, retailers, or other external partners.
- e) The S\$10 Lendlease voucher shall be issued in the form of one (1) piece of S\$10 Lendlease voucher or Lendlease E-Voucher to qualifying members.

- i) To receive the S\$10 Lendlease voucher(s) or S\$10 Lendlease E-Voucher(s), the eligible Citi Cardmember must present up to a maximum of three (3) same-day Parkway Parade receipts, Card Charge Slip and corresponding Citi Card at Parkway Parade L2 Concierge Desk only (Last redemption at 9.30pm).
- j) Redemption must be made on the same day as purchase and is limited to one (1) redemption per Citi Cardmember per day.
- k) Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.

- b) Retailers' E-Vouchers will be launched at 12pm on Fridays – 10, 17, 24, 31 May and 7, 14, 21 June 2024.
- c) All redemptions are available till 30 June 2024 on a first-come, first-served basis and while stocks last.

- v. Receipts less than S\$10 in value are not acceptable for Plus\$ earning.

- xvi. The Management's decision on all matters relating to the Promotion is final, conclusive and binding on all persons. No correspondence will be entertained.
- xvii. Parkway Parade and The Management make no representation as to the merchantability or quality of the products and services of its tenants. Upon redemption, customers enter a contract with the tenants and disputes shall be resolved directly with them.
- xviii. The Management and its authorized agencies shall not be liable for any injury, damage or loss arising out of or in connection with the Promotion, and each participant agrees to indemnify and hold The Management harmless from and against any and all claim, loss or damage incurred by the participant or by any other party in relation to the Promotion.
