

## Shop Stack Save (13 March – 26 April 2026)

### Terms and Conditions

#### 1. Sweet Savings *LENDLEASE PLUS MEMBERS EXCLUSIVE*

13 March – 26 April 2026

- 1.1. Lendlease Plus Members are eligible to redeem 10,000 Plus\$ with a minimum nett spend of S\$200 at Parkway Parade, within a maximum of three (3) combined same-day receipts.

- 3.5. S\$5 Lendlease voucher shall be issued in the form of one (1) piece of physical S\$5 Lendlease voucher to qualifying non-Lendlease Plus Members or one (1) piece of S\$5 Lendlease E-Voucher to qualifying Lendlease Plus Basic Members.
- 3.6. S\$10 Lendlease voucher shall be issued in the form of one (1) piece of S\$10 Lendlease E-Voucher to qualifying Lendlease Plus Premium Members.
- 3.7. S\$5 or S\$10 Lendlease voucher shall be issued based on the Lendlease Plus Membership tier at the point of redemption at L2 Concierge Desk, regardless of approval status of eligible purchase receipt(s) at the point of sale at Instant Earn participating stores or submitted on the Lendlease Plus mobile app to earn Plus\$ based on their qualified transaction.
- 3.8. S\$5 Lendlease voucher is limited to the first 790 HSBC Credit Cardmembers only on a first-come-first-served basis and while stocks last.
- 3.9. S\$10 Lendlease voucher is limited to the first 700 HSBC Credit Cardmembers only on a first-come-first-served basis and while stocks last.
- 3.10. The Qualifying Spend is based on up to three (3) combined same-day receipts.

To receive the S\$5 or S\$10 Lendlease voucher, the eligible HSBC Credit Cardmember must present up to a maximum of three (3) same-day Parkway Parade receipts, Card Charge Slip and corresponding HSBC Credit Card at Parkway Parade L2 Concierge Desk only from 11.30am - 8.30pm. Concierge will only issue the S\$5 or S\$10 Lendlease voucher. Lendlease Plus Members are required to clock their spends at the point of sale at Instant Earn participating stores or submit their eligible purchase receipt on the Lendlease Plus mobile app to earn Plus\$ based on their qualified transaction.
- 3.14. Redemption must be made on the same day as purchase and is limited to one (1) redemption per HSBC Credit Cardmember per day.
- 3.15. Vouchers issued cannot be exchanged for other denominations, cash and other gift prizes/ vouchers.

#### **4. Blumora Shopping Voucher**

14 - 22 March 2026

- 4.2. Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.

Concierge will only issue the S\$5 Blumora physical voucher. - 5.2. Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- 5.3. - iv.
