### Terms and Conditions

#### 1. Y.W.B.I.T Roving Exhibition & Collection Drive LENDLEASE PLUS MEMBERS EXCLUSIVE

24 May – 4 Jun 2023 (both dates inclusive)

- a. Lendlease Plus Members who deposit their qualifying textiles via the onsite smart vending machine from 24 May to 4 June 2023 between 10am to 10pm at Parkway Parade, Basement Airwell will be able to redeem Lendlease Plus\$.
- b. Lendlease Plus Members are required to scan their unique in-app Lendlease Plus membership QR code before depositing their qualifying textiles into the onsite smart vending machine to earn Lendlease Plus\$. To locate the unique Lendlease Plus membership QR code, members can click on 'My QR' on the Home tab in the Lendlease Plus mobile app. Qualifying textiles and awardable Lendlease Plus\$ as follow:
