



A Joyful Christmas At Play (16 Nov - 31 Dec 2023)

Terms and Conditions

1) Gift Of Surprise

16 Nov – 25 Dec 2023 (both dates inclusive)

- a) Shoppers are eligible to redeem one (1) piece of Christmas gift wrapper with every S\$30 nett spend in a single receipt at Parkway Parade.
- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) Redemption must be made on the same day of purchase at L2 Concierge Desk from 10am to 9.30pm daily.
- d) Limited to a maximum of three (3) redemptions per shopper per day, regardless of total amount spent.
- e) Limited to first 30,000 redemptions throughout the entire promotion period, on a first-come first-served basis or while stocks last.
- f) All redemptions are further subject to the General Terms and Conditions as set out below.

- b) Receipts from CS Fresh and FairPrice Xtra require double spending for redemption.
- c) To receive 10,000 Plus\$, Lendlease Plus Members can clock their spends by uploading receipts via the Lendlease Plus mobile app on the same day as purchase. Plus\$ will be credited to their wallet in-app upon approval of qualifying receipt(s) within two (2) working days.

3) Citi Cardmembers Exclusive
